

### INSTALLATION AND MOUNTING


Read instructions and check you have all the tools and accessories to complete the installation correctly. Isolate the mains power supply before commencing installation.



Separate diffuser from base plate by twisting diffuser in an anti-clockwise direction.



Set the desired temperature to warm white, cool white or daylight.




Securely fix base plate to mounting surface (ceiling/wall) using secure fixing methods, ensuring that centre hole in base plate aligns with mains power cable in. Fixing holes are provided on the base plate or new ones may be drilled to suit. Draw the mains power cable through the hole in the base plate in preparation for connection.

Connect mains power cable to terminal block on base plate.



Reattach diffuser to base plate by twisting diffuser in a clockwise direction until secure. Your fitting is now ready for use.



### REPLACING THE BATTERY

Access battery by removing product cover. Disconnect and remove battery. Replace battery as was previously installed. Battery can be connected in one direction only, do not force. Allow a minimum of 24 hours charging time before carrying out any discharge tests as per the requirements in AS/NZS 2293.

### **BATTERY LIFE**

To maintain the economic life of this product it is required that the battery be discharged and recharged at least once every 6 months. The battery life can be reduced if the battery is not discharged as per the requirements of AS/NZS 2293 or an equivalent standard. Increasing the number of duration tests above that as defined in AS/NZS 2293 or an equivalent standard can have a positive effect on the battery performance as long as 12 discharge cycles per year is not exceeded. The recharging device will operate normally after removal of short circuit fault.






